Deadline and Early Discount

Applications must be received by Friday, August 30, 2019 to take advantage of the early deadline discount. All fees are due with application. Cancellations will be refunded until August 30, 2019. All other applications excluding early discount are due no later than October 15, 2019. The festival will take place rain or shine. Approximately one week before the festival, vendors will receive site confirmation and detailed information via U.S. Postal Mail and or email whichever you prefer.

Eligibility

Food vendors may not sell food items purchased for resale. No Donation Soliciting Allowed. Raffles must be preapproved by the festival, are limited to non-profits only, and must comply with Georgia law.

The number of vendors offering the same type of food/products and or arts & crafts products will be limited as well as the total number of food & craft vendors. The festival does not guarantee that any booth will have sole rights to sell a product, but both vendors and festival goers appreciate a range of food and crafts choices. Food vendors are expected to follow cleanliness and food safety practices.

Set-up/Breakdown

Exhibitors must provide their own displays, tables, chairs, extension cords, tents, etc. Be prepared for the weather (wind, rain, etc.) Electricity will only be provided to the vendors specifying on their application it is needed on their vendor application. No part of the vendor’s display, including tent, may extend past the 12 x 12 space provided. A dining area is provided near the festival area. Vendors may set up their own dining areas within their booth spaces. No part of the dining areas may extend past the booth space. Vendors may set up on Friday evening after 5:00 p.m. However, the festival is not responsible for security overnight and will not be responsible for any damage or theft of property if occurring from early setup. **Saturday set-up is between 7:30 a.m. and 9:45 a.m.** Vendors

must be unloaded and vehicles moved by 9:30 a.m. Vendor parking is provided nearby. **Breakdown is after 5:00 p.m. No set-up or breakdown will be allowed during show hours.**

Clean-up

All trash, garbage and cooking oil must be removed from the booth space at the end of the day. A dumpster will be provided nearby for deposit of trash and garbage. Proper storage & disposal of oil is required. Vendor will be held accountable for any spill by the County and/or the Taylor Made Fall Festival.
